



## Autobell Fundraising Program

### How to Get Started

The following information outlines the Autobell® Fundraising Program options and organizational requirements. ### Autobell Car Wash Fundraising Program Options

#### Option 1: The Pre-Sell Program

*This program is recommended for all new organizations.*

Organization Responsibilities:

- Agree to pre-sell **\$20** Autobell® Fundraiser Gift Cards at the full retail price.
- Advise Autobell the total number of pre-sold gift cards no later than the due date indicated on the signed agreement.
- **Pay Autobell® \$10 for each gift card.**
- Provide Autobell® seven (7) days to process the gift cards after payment has been received.

#### Option 2: The Pre-Paid Program

Organization Responsibilities:

- Agree to sell **\$20** Autobell® Fundraiser Gift Cards at the full retail price.
- **Pay Autobell® \$10 for each gift card.**
- Provide Autobell® seven (7) days to process the gift cards after payment has been received.

#### Option 3: Partial Pay Program

Organization Responsibilities:

- Agree to sell **\$20** Autobell® Fundraiser Gift Cards at the full retail price.
- **Pay Autobell® \$10.00 for each gift card.**
- **Provide Autobell a partial payment which is 50% of the total amount due. This payment is due prior to shipment of gift card packet.**
- Submit remaining balance payment to Autobell Car Wash, Inc. no later than the due date indicated on the signed agreement.
- This program is for Organizations that have worked with the Autobell Fundraiser Program within the last 3 years. Organizations may request up to 100 gift cards to get started. Once the initial gift cards are sold, additional may be requested within your 30-day fundraising period.

**Note: \*Special terms and conditions may apply for each program. Gift Cards cannot be returned once received by the organization and are 100% non-refundable. Any lost or stolen gift cards cannot be replaced.**

### **Organization Requirements**

- Must be a non-profit 501(c)(3) organization.
- Provide a valid federal tax ID number.
- The chairperson, treasurer, or business manager must be at least 21 years of age.
- Each organization is allowed to participate in the Autobell® Fundraising Program one (1) time within a 12-month period.

### **Chairperson responsibilities:**

- Complete the online application at [www.autobell.com/fundraising](http://www.autobell.com/fundraising) .  
*\* All applications are subject to review and approval.*
- Sign the Autobell® Fundraising agreement.
- Provide payment to Autobell Car Wash, Inc. for all issued gift cards. The following are acceptable forms of payment:
  - certified bank check made payable to Autobell® Car Wash
  - credit or debit card
  - money order

### **Organization responsibilities:**

- Only sell Autobell® gift cards at the full retail price of \$20.
- Keep \$10 per gift card issued to the organization and pay \$10 to Autobell®.
- Complete the fundraising event within 30 days.
- Submit payment to Autobell® prior to gift cards being shipped to the organization\*
